IF YOU REQUEST THIS ACCOUNTING MORE THAN ONCE IN A 12-MONTH PERIOD, WE MAY CHARGE YOU A REASONABLE, COST-BASED FEE FOR RESPONDING TO THESE ADDITIONAL REQUESTS.
